**VI. INSTRUCTIONS FOR COMPLETING APPLICATION**

GENERAL: Mechanical work shall not be started until the application for permit has been filed with the Keweenaw County Building Department. All installations shall be in conformance with the Michigan Mechanical Code. **No work shall be concealed until it has been inspected.** When ready for an inspection, call the inspector providing as much advance notice as possible. The inspector will need the job location and permit number. A New home requires three inspections, underground, rough and final.

**VII. FEE CLARIFICATION**

ITEM #2, Residential Heating System: This item is used for the installation of a heating system in a new residential structure. Items #10 Gas Piping and #18 Duct should not be charged. Replacement systems should be itemized.

**VIII. PLAN REVIEW REQUIRED**

**Plans must be submitted with this application and the appropriate fee before a permit can be issued, except as listed below:**  
Plans are not required for the following:  
1. When the the building is not over 3,500 square feet in area. 2. Alterations and repair work determined to be of a minor nature by the mechanical inspector; 3. Work completed by a Governmental Subdivision or State Agency costing less that \$15,000.00; 4. One and two family dwellings when the total building heating/cooling system input rating is 375,000 Btu's or less.

Plans which are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No. 299 of the Public Acts of 1980, as amended, and shall bear the architect's or engineer's signature and seal.

**IX. APPLICANT / HOME OWNER SIGNATURE**

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND/OR CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CAN BE REOPENED FOR A FEE OF \$75.00.**
